## **QUESTION THREE (20 MARKS)**

James took a job as a convenience store clerk to supplement the income of his financially struggling family. One night a masked gunman came in to the store branding a hand gun. The gun man demands that James open the cash register and give him all of the money inside.

During the course of the event James has a heart attack and drops to the floor dead. The gunman thought he had fainted and he open the register himself and empties out all the cash.

When the police and paramedics arrive, they found that James had died but, there was no sign of bullet wounds or other trauma. An autopsy confirms that he died of a heart attack. The gun man was eventually arrested.

- a. Advise the police on what two charges should be brought against the gun man. (5 marks)
- b. Describe the element of criminal liability in the case. (5 marks)
- c. State five constitutional rights that the gun has as an accused person. (5 marks)
- d. If the gunman is found guilty. Describe two possible sanctions he is likely to serve.
